

1. The **Promoter** is Western Australia Cricket Association, Gate 2, Nelson Crescent, East Perth, WA 6004
2. Information on how to enter [the Promotion] and prizes forms part of these Terms and Conditions. Participation in this promotion is deemed acceptance by the Entrant of these Terms and Conditions.
3. Employees (and their immediate families) of the Promoter are ineligible to enter. Employees (and their immediate families) of the Promoter and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or first cousin.
